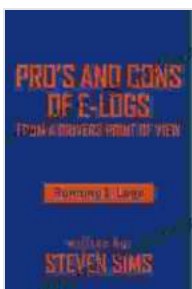


Pros and Cons of Logs from a Driver's Point of View: RUNNING LOGS

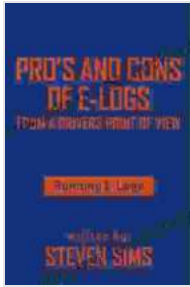

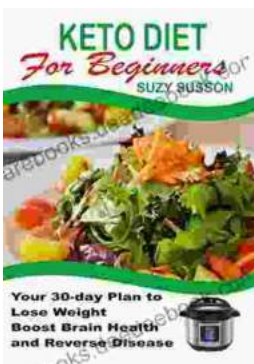
